Candidates must have signatures from petitions certified with the County Clerk at 522 South Adams, Auditor's Office, Room 101 **prior** to filing petitions with the Taxing District Clerks no later than 5:00 p.m. on March 18, 2011.

Individuals who run as write-in candidates must file a declaration of intent no later than 5:00 p.m. on April 1, 2011.

All districts except Cities have a provision which allows them not to conduct an election if only one candidate has filed for any position. This determination can only be made after the filing deadline for the write-in candidates has passed.
