PRIOR TO THE ELECTION**

**MUST BE A REGISTERED VOTER
ELECTION DAY REGISTRATION AT THE POLLING PLACES IS AVAILABLE
WITH PROPER VOTER IDENTIFICATION AND PROVIDING PROOF OF RESIDENCY**

**VOTERS WHO HAVE CHANGED THEIR NAME OR ADDRESS SINCE THE
PREVIOUS ELECTION ARE REQUIRED TO RE-REGISTER**
